#4 – Vote: Defeated by a vote of 59-104, after amending the proposal

Amended to correct proposal by adding a "." After the words "Standing Committees. " On the last line on page 3.)

Amend #2: add at the end of the amendment: "Special Committees may be drawn from the entire membership."

Additional amendments were discussed, with a point of order: a proposal that is Amended a third time, by Roberts Rules, is required to be withdrawn. Ruling from Parliamentarian was that the body could vote on the Amended Amendment, with the first 2 amendments to the proposal. We then voted on amendment #4, as amended by the 1st 2 amendments and it was defeated by a vote of 59-104.

#5 - Withdrawn by maker, based on #4

#6 - Withdrawn by maker

#7 – **Adopted as amended.** First motion to amend... ADA is "American's with Disabilities Act". Withdrawn... because we are an international organization.

Amend... "...meet the guidelines of their respective country's laws." - Adopted

#11 - Adopted as amended. Amended to say "may" not "shall" in line #1.


#12 - **Amended amendment was adopted** 121-52. Amended by deleting extra "," on line 3, after the words "including any"

HOUSEKEEPING

#1 & #2 housekeeping

Both amendments to proposals #1 and #2 had to be withdrawn. According to HL June Haas, PSRM, these must match the Articles of Incorporation, which are part of the Constitution and still not updated!

#2. Amended to match #1, by adding "Order of the Triangle & Constellation..." passed. <u>As amended, #2 & #1 passed.</u> It took us 15+ minutes to do these 2 simple changes. This is going to be a long process!

Additional Housekeeping

#7 & 45 are both spelling errors: #7 Visting to Visiting and #45 "is" to "it" **Both adopted**

#47 Spacing error, moving the heading on bottom of page 147 of Ritual "Conductress and Assoc Conductress" to top of next page 148.

SK Stoney Pavlich moved that the items of formatting, spelling, and capitalization (punctuation and spacing were also mentioned in discussions) be taken care of in the printing process. It was not necessary to go through these individually.

#66 - new section - Obligation for Master Masons (Pages 23-24 of the packet).

- At the top of page 24... error in 6th line, the response of Royal Patron is made by the AC. Change RP: to AC. **PASSED**
- Continuing with Master Mason obligation... change places where it says "Brother" to "visiting Mason". Discussion.... about who calls a Mason "Brother". **Revision FAILED**

- Moved by Diana Moulden, WA... where public sign is made, it should be before the spoken word. We rise, salute, then speak. This needs to be changed throughout this proposal. <u>PASSED</u>
- Page 23, 6th line from the bottom, should be unbolded and placed in parentheses. (RM hands the gavel to the RP). This is a direction. **PASSED**
- Jeanne Milton- moved to remove the ceremony. She suggested the RP can give an obligation using the Bible on the secretary's desk. There was a little discssion on this... What I kept hearing from the audience was this was a negative motion... and was not appropriate. If we just vote the proposal down, it will not be included.
- We voted to approve the ritual proposal, as amended. <u>It was DEFEATED & will not be</u> included.

- On page 117 (Pg 5 of proposed amendments) add the same phrase after RM charge. ADD: Members of other sovereign nations will stand in respect. Adopted.

• 2 amendments adopted on page 9 of the proposed amendments, page 45 of the Ritual (previously on page 48), paragraph 2 of the proposed change, create a new paragraph "When more than none officer..." (end of line). Adopted. AND. Onn the same page, same section, delete the words,,

"without escort" in the last line. Adopted.

- Amend to delete Elective, and change "an" to "a" (page 45 (previously 48) in the paragraph beginning "Officers escorted to the Throne..." in the middle of the paragraph, ...A PGRM or PGRP holding *a* an Elective...." Adopted

At this time, it was decided that we could not get through the rest of the Ritual Revisions at this session. It was moved to suspend the Rules governing Ritual Revision (which is every 10 years) and proposed Ritual changes not considered today be brought up at the 127th assembly. This motion required unanimous consent, which it did not get. One or more persons voted "no." There was then a reconsideration of that vote, and we voted again and the motion passed unanimousely.

There are16-20 remaining Ritual revision proposals. It is unclear when the Ritual changes adopted at this 126th session will become effective. We will be informed by SRM Bizzy Herbolsheimer in the near future. As revised, Ritual pages will be printed to be replacement pages to the current green Ritual.
